1 WHEREAS, the San Lucy District did request an advancement of \$100,000.00 on
2 their royalties to be used on their economic development project; and

3 WHEREAS, the Tohono O'Odham Legislative Council is supportive of the proposal
4 submitted by San Lucy District; and


5 WHEREAS, the Tohono O'odham Legislative Council sees a need to support economic
6 development by all districts of the Nation.

8 NOW, THEREFORE, BE IT RESOLVED that all districts of the Tohono O'Odham Nation
9 is hereby granted \$100,000.00 each to be used for Economic Development
10 Projects.


11 BE IT FURTHER RESOLVED that each District shall present their proposal to the
12 Tohono O'Odham Legislative Council for approval.

14 The foregoing resolution was passed by the Tohono O'odham Council on the 5th
15 day of November, 1986, at a meeting at which a quorum was present with a vote
16 of 956.5 for; 545.5 against; -0- not voting; and 138.0 absent, pursuant to the
17 powers vested in the Council by Section 1 (d) (2) of Article VI of the Consti-
18 tution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
19 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
20 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
21 of June 18, 1934 (48 Stat. 984).




