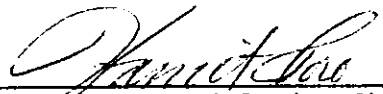
26 THEREFORE, BE IT RESOLVED that it is hereby determined that the above

32 the Tohono O'odham Nation reduce this final determination in writing

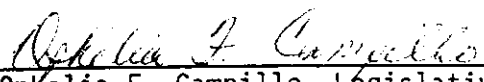
1 regarding each of the foregoing applications for enrollment in ac-  
2 cordance with Section 3 (c) of Article III of the Enrollment Ordi-  
3 nance; give notice of this Council's determination in accordance with  
4 Section 4 of Article III of the Enrollment Ordinance; and place the  
5 names of each applicant upon the membership roll of the Tohono O'odham  
6 Nation in accordance with Article V of the Enrollment Ordinance.

8 The foregoing resolution was passed by the Tohono O'odham Council on the 7th  
9 day of November, 1986, at a meeting at which a quorum was present with a vote  
10 of 1514.0 for; -0- against; -0- not voting; and 126.0 absent, pursuant to the  
11 powers vested in the Council by Section 1 of Article II and of Section 1 (h) of  
12 Article VI of the Constitution of the Tohono O'odham Nation, adopted by the  
13 Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy  
14 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to  
15 Section 16 of the Act of June 18, 1934 (48 Stat. 984).
