The foregoing resolution was passed by the Tohono O'odham Council on the $\frac{7th}{day}$ of November, 1986, at a meeting at which a quorum was present with a vote of 1514.0 for; -0- against; -0- not voting; and 126.0 absent, pursuant to the powers vested in the Council by Section 1 of Article II and of Section 1 (h) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
