1 WHEREAS, CHUHUHUA, Alicia; has made application for adoption in the Tohono  
2 O'odham Nation pursuant to Section 2 of Article II of the Constitution  
3 of the Tohono O'odham Nation; and

4 WHEREAS, The Enrollment Committee has reviewed the respective application, had  
5 made a final determination that they are 1-1/2 degree or more of  
6 Papago-Tohono O'odham Indian blood, and have made a recommendation to  
7 the Tohono O'odham Council that the application be approved, all in  
8 accordance with the provisions of the Enrollment Ordinance; and

9 WHEREAS, The Tohono O'odham Council has reviewed the recommendation of the En-  
10 rollment Committee and the evidence submitted in support of the  
11 individual application.


13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that the appli-


17 is hereby approved and is hereby adopted into membership of the Tohono

22 powers vested in the Council by Section 2 of Article II and Article VI Section  
23 1(h) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
24 O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant  
25 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
26 16 of the Act of June 18, 1934 (48 Stat. 984).
