

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Refer status of Noranda to various committees for further discussion)

RES. NO. 530-86

1 WHEREAS, the Tohono O'Odham Legislative Council is aware that Noranda is seeking
2 ways to cut expenses by December 31, 1986; and

3 WHEREAS, the Tohono O'Odham Legislative Council did authorize to seek funding
4 from the Bureau of Indian Affairs to assist Noranda Mine; and

5 WHEREAS, all the alternatives must be considered, including the possibility of
6 writing off \$960,000.00 owed to the Tohono O'Odham Nation; and

7 WHEREAS, the possible closure of the Mine will impact the economy of the Tohono
8 O'Odham Nation.



10 NOW, THEREFORE, BE IT RESOLVED that the Natural Resources Committee and Budget
11 & Finance Committee are to discuss and make recommendations to the
12 Tohono O'Odham Legislative Council on options or alternatives the
13 Nation could take regarding Noranda Mine.

14 BE IT FURTHER RESOLVED that a shut down will have a direct impact on All the
15 Nations Branch's cost of operating.


16 BE IT FURTHER RESOLVED that the Nation is to make preparation in the event the
17 Mine shuts down because our future royalties will not be realized.

19 The foregoing resolution was passed by the Tohono O'odham Council on the 17th
20 day of November, 1986, at a meeting at which a quorum was present with a vote
21 of 1454.0 for; 117.0 against; 69.0 not voting; and 01 absent, pursuant to the
22 powers vested in the Council by Section 1 (d)(2) of Article VI of the Consti-
23 tution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).





5 either approve or disapprove it within 48 hours of submittal.


