1 WHEREAS, An application for enrollment as a member of the Papago Tribe of the  
2 the Papago Reservation has been filed by or on behalf of:

3 Maria De Los Angeles Pacheco No District  
4 ("Applicant") (Namely Application No.)

5 filed on the 31st day of August, 19 85; and

6 WHEREAS, The Enrollment Committee has reviewed the application and has recom-  
7 mended that the application be denied because the applicant failed  
8 to establish the membership requirements of Section 1 of Article II  
9 of the Constitution of the Papago Tribe, as amended; and

10 WHEREAS, The application has come on for hearing before this Council; and

11 WHEREAS, The Enrollment Committee did publish written notice of its recommen-  
12 dation to reject the application and of this hearing, as required by  
13 Section 2, Article IV of the Papago Enrollment Ordinance, amended  
14 by Resolution No. 349-85, and neither the applicant or applicant's  
15 sponsor appeared at this hearing; and

16 WHEREAS, The Papago Council has reviewed all of the evidence presented and  
17 from such evidence finds that the applicant has failed to establish  
18 the foregoing membership requirement(s).

19 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
20 determine that the application of:

21 Maria De Los Angeles Pacheco


22 for enrollment as a member of the Papago Tribe is hereby rejected.

23 BE IT FURTHER RESOLVED that the Chairman of the Papago Council shall issue a  
24 Certificate of Final Determination of Rejection and that the Enroll-

26 accordance with the provisions of Section 1 and 2, Article VIII of  
27 of the Papago Enrollment Ordinance, as amended by by Resolution No.  
28 349-85 of the Papago Council.

Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
