7 mended that the application be denied because the applicant failed  
8 to establish the following membership requirement(s): PAPAGO  
9 CONSTITUTION & BY-LAWS ARTICLE II MEMBERSHIP - SECTION (1A) & (1B);

11 WHEREAS, The application has come on for hearing before this Council; and

12 WHEREAS, The Enrollment Committee did serve written notice of its recommen-  
13 dation to reject the application and of this hearing, as required by  
14 Section 2, Article VI of the Papago Enrollment Ordinance, upon the  
15 person who filed the application and such person was/was not present  
16 at this hearing; and

17 WHEREAS, The Papago Council has reviewed all of the evidence presented and  
18 from such evidence finds that the applicant has failed to establish  
19 the foregoing membership requirement(s).

21 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
22 determine that the application of: MICHELLE LEE McNEAL


23 for enrollment as a member of the Papago Tribe is hereby rejected.

25 BE IT FURTHER RESOLVED that the Chairman of the Papago Council shall issue a  
26 certificate of Final Determination of Rejection and that the Enroll-  
27 ment Committee serve Notice of Rejection of the application in  
28 accordance with the provisions of Section 1 and 2, Article VIII of  
29 of the Papago Enrollment Ordinance.

Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
