WHEREAS, The Papago Council has reviewed all of the evidence presented and from such evidence finds that the applicant does not have one-half degree or more of Papago Indian blood as required by Section 1(b) of Article II of the Papago Constitution.

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby determine that the applicant of:

RUBEN L. SALAZAR

for adoption as a member of the Papago Tribe is hereby rejected.

BE IT FURTHER RESOLVED that the Chairman of the Papago Council shall issue a certificate of Final Determination of Rejection and that the Enrollment Committee serve Notice of Rejection of the application in accordance with the provisions of Section 1 and 2, Article VIII of the Papago Enrollment Ordinance.

The foregoing Resolution was duly enacted by the Papago Council on the 27th day of <u>February</u>, 1986, at a meeting at which a quorum was present with a vote of 1492.5 for; 147.5 against; -0 not voting; and 01 absent, pursuant to
