

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
(Rejection of application for adoption)  
(of FERNANDO SALAZAR)

1 WHEREAS, An application for adoption as a member of the Papago Tribe of the  
2 Papago Reservation has been filed by or on behalf of:

4 FERNANDO SALAZAR 703-GV-74  
("Applicant") (Namely Application No.)

5 filed on the 30TH day of DECEMBER, 1974; and

6 WHEREAS, The Enrollment Committee has reviewed the application and has recom-  
7 mended that the application be denied because the applicant is not  
8 one-half degree or more of Papago Indian blood; and

9  
10 WHEREAS, The application has come on for hearing before this Council; and

11 WHEREAS, The Enrollment Committee did serve written notice of its recommen-  
12 dation to reject the application and of this hearing, as required by  
13 Section 2, Article VII of the Papago Enrollment Ordinance, upon the  
14 person who filed the application and such person was/was not present  
15 at this hearing; and

16 WHEREAS, The Papago Council has reviewed all of the evidence presented and  
17 from such evidence finds that the applicant does not have one-half  
18 degree or more of Papago Indian blood as required by Section 1(b) of  
19 Article II of the Papago Constitution.

21 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
22 determine that the applicant of:

23 FERNANDO SALAZAR

24 for adoption as a member of the Papago Tribe is hereby rejected.

26 BE IT FURTHER RESOLVED that the Chairman of the Papago Council shall issue a  
27 certificate of Final Determination of Rejection and that the En-  
28 rollment Committee serve Notice of Rejection of the application in  
29 accordance with the provisions of Section 1 and 2, Article VIII of  
30 the Papago Enrollment Ordinance.

31 The foregoing Resolution was duly enacted by the Papago Council on the 27th  
32 day of February, 1986, at a meeting at which a quorum was present with a vote  
of 1492.5 for; 147.5 against; -0- not voting; and 01 absent, pursuant to

1 the authority vested in the Papago Council by Article II and Section 2 (f) of  
2 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as  
3 amended, ratified by the Papago Tribe on December 12, 1936, and approved by the  
4 Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act  
of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by  
the Secretary of the Interior and is effective as of the date of its enactment  
by the Papago Council.
