IT FURTHER RESOLVED traditional Tribal means of citizen BE followed through District involvement were Council O'odham Legislative Council meetings and Tohono to articulate needs, meetings, opportunity express about proposed community development and preferences assist in the selection of district housing activities, priorities, and otherwise participate in the development of the application.

BE IT FURTHER RESOLVED that no part of this paragraph shall be construed to restrict the responsibility and authority applicant for development of the application and the execution of its Community Development Block Grant Program.
