

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Citizen Participation Certification)

RES. NO. 04-88

1 WHEREAS, the Tohono O'odham Nation has submitted an application
2 for a grant to fund certain eligible Indian Community
3 Development Block Grant Program activities and in
4 connection with such application resolved and made
5 certain assurances.

6 NOW, THEREFORE, BE IT RESOLVED that prior to the submission of
7 its application, the governing body of the Tohono
8 O'odham Nation has provided tribal citizens through
9 their Council Representatives especially those living in
10 areas where activities are proposed or ongoing with
11 adequate information concerning the amount of funds
12 available for proposed community development and housing
13 activities, the range of activities that may be
14 assisted, and other important program requirements and
15 solicited their views and participation.

16 BE IT FURTHER RESOLVED traditional Tribal means of citizen
17 involvement were followed through District Council
18 meetings and Tohono O'odham Legislative Council
19 meetings, opportunity to articulate needs, express
20 preferences about proposed community development and
21 housing activities, assist in the selection of district
22 priorities, and otherwise participate in the development
23 of the application.

24 BE IT FURTHER RESOLVED that no part of this paragraph shall be
25 construed to restrict the responsibility and authority
26 of the applicant for development of the application and
27 the execution of its Community Development Block Grant
28 Program. Accordingly, the citizen participation
29 requirements of this paragraph do not include
30 concurrence by any person or group involved in citizen
31 participation in making final determinations concerning
32 the findings and contents of the application.

1 The sole responsibility and authority to make such final
2 determinations rest exclusively with the Tohono O'odham
3 Legislative Council.

4 The foregoing resolution was passed by the Tohono O'odham
5 Council on the 4th day of January, 1988, at a meeting at which a
6 quorum was present with a vote of 1,640.0 for; -0- against; -0-
7 not voting; and 03 absent; pursuant to the powers vested in the
8 Council by Section 1 (c)(2) (d)(2) & (f) of Article VI of the
9 Constitution of the Tohono O'odham Nation on January 18, 1986,
10 and approved by the Acting Deputy Assistant Secretary - Indian
11 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
12 the Act of June 18, 1934 (48 Stat. 984).
