WHEREAS, the Elderly proposal will benefit elder members of the Tohono O'Odham Nation by providing for their nutritional and social support services.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does hereby approve the proposal for continued funding of the Elderly Program to provide services to eligible members of the Tohono O'odham Nation.

BE IT FURTHER RESOLVED that the term of this grant shall commence on April 01, 1988 and end on March 31, 1989.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Chairman, Vice-Chairman and Treasurer of the Tohono O'odham Nation are hereby authorized to negotiate and execute this grant and any amendments thereto for the duration of this grant, provided however, that any amendments affecting the funding or funding levels of this grant shall be submitted for further prior approval by this Council.

The foregoing resolution was passed by the Tohono O'odham Council on the 5th day of January, 1988, at a meeting at which a quorum was present with a vote of 1,555.0 for; -0- against; 58.5 not voting; and 01 absent; pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 934).
