LEGISLATIVE ORDER OF THE TOHONO O'ODHAM COUNCIL (Tabling Issue on All Districts IIM Account)

LEGIS. ORDER NO. 09-88

WHEREAS, the Legislative Council addressed the San Lucy District Resolution No. 53-87 "All Districts IIM Account" which requests payment of \$600,735.47 owed by the Tohono O'odham Nation to the All Districts IIM Account; and

whereas, members of the Budget and Finance Committee informed the Council that the issue of funds owed by the Nation to the District IIM Account is a part of their running agenda; and

whereas, the Committee is aware of the District's concern surrounding the outstanding debt by the Tohono O'odham Nation, but the issue has been complicated by the lack of financial records to justify if the true amount owed is \$600,735.47.

NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that the issue of repayment to the All Districts IIM Account of \$600,735.47, as requested by the San Lucy District resolution, be tabled.

BE IT FURTHER RESOLVED that the issue be brought back to the Council in 60 days.

The foregoing order was passed by the Tohono O'odham Council on the 5th day of January, 1988, at a meeting at which a quorum was present with a vote of 1,640.0 for; -0- against; -0- not voting; and 01 absent; pursuant to the powers vested in the Council by Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
