

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM COUNCIL  
(Tabling Issue on All Districts IIM Account)

LEGIS. ORDER NO. 09-88

1 WHEREAS, the Legislative Council addressed the San Lucy District  
2 Resolution No. 53-87 "All Districts IIM Account" which  
3 requests payment of \$600,735.47 owed by the Tohono  
4 O'odham Nation to the All Districts IIM Account; and

5 WHEREAS, members of the Budget and Finance Committee informed  
6 the Council that the issue of funds owed by the Nation  
7 to the District IIM Account is a part of their running  
8 agenda; and

9 WHEREAS, the Committee is aware of the District's concern  
10 surrounding the outstanding debt by the Tohono O'odham  
11 Nation, but the issue has been complicated by the lack  
12 of financial records to justify if the true amount owed  
13 is \$600,735.47.

14 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that  
15 the issue of repayment to the All Districts IIM Account  
16 of \$600,735.47, as requested by the San Lucy District  
17 resolution, be tabled.

18 BE IT FURTHER RESOLVED that the issue be brought back to the  
19 Council in 60 days.


20 The foregoing order was passed by the Tohono O'odham Council on  
21 the 5th day of January, 1988, at a meeting at which a quorum was  
22 present with a vote of 1,640.0 for; -0- against; -0- not voting;  
23 and 01 absent; pursuant to the powers vested in the Council by  
24 Section 1 (a) of Article VI of the Constitution of the Tohono  
O'odham Nation on January 18, 1986, and approved by the Acting  
Deputy Assistant Secretary - Indian Affairs (Operations) on March  
6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
Stat. 984).
