WHEREAS, one reason cited is the Council waiving of Article XII,

Section 3.K (Special Requirements/Eligibility of

Candidates) by Resolution No. 203-87 to allow

Legislative Members to sit on three or more Committees;

and

WHEREAS, the Legislative Council can either reaffirm its

Legislative Rules and take corrective action on those

Council members who are on less than or more than three

committees, or amend the Legislative Rules.

NOW, THEREFORE, BE IT RESOLVED by the Legislative Council to reaffirm and abide by the Legislative Rules adopted by Resolution No. 172-87 on May 1, 1987.

BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative Council abide by the Legislative Rules which states "A Legislative Representative may serve on three (3) but no more than three (3) Legislative Committees.

The foregoing Legislative Order was passed by the Tohono O'odham Council on the 2nd. day of May, 1988 at a meeting at which a quorum was present with a vote of 1,390.0 for; 63.0 against; 187.0 not voting; and 02 absent, pursuant to the powers vested in the Council by Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
