

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting Criminal Code of the Tohono O'Odham Nation)

RES. NO. 107-88

1 WHEREAS, the Judiciary and Domestic Affairs Committees of the
2 Tohono O'Odham Legislative Council have reviewed the
3 Criminal Code of the Papago Tribe enacted by Ordinance
4 No. 02-85 on April 11, 1985, in light of the
5 Constitution of the Tohono O'Odham Nation and the
6 enactment by Congress of the Omnibus Drug Enforcement,
7 Education and Control Act of 1986, and have recommended
8 the adoption of the attached proposed changes and
9 additions to the Criminal Code of the Tohono O'Odham
10 Nation in place thereof; and

11 WHEREAS, the foregoing legislative committees have conducted
12 public hearings thereon in the various Districts of the
13 Tohono O'Odham Nation advising the O'Odham of the
14 changes envisioned by the Criminal Code.

15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
16 Council that it does hereby enact the attached proposed
17 changes and additions to the Criminal Code of the Tohono
18 O'Odham Nation as recommended by the Judiciary and
19 Domestic Affairs Committee with the exception of number
20 six (6), the addition of new fresh pursuit 1.19, and
21 extradition 1.20 provisions.

22 The foregoing resolution was passed by the Tohono O'odham Council
23 on the 2nd day of May, 1988 at a meeting at which a quorum was
24 present with a vote of 1,524.5 for; 115.5 against; -0- not
25 voting; and 02 absent, pursuant to the powers vested in the
26 Council by Section 1 (c) of Article VI of the Constitution of
27 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
28 on January 18, 1986, and approved by the Acting Deputy Assistant
29 Secretary - Indian Affairs (Operations) on March 6, 1986,
30 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
31 984).
