

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tabling recommendation for Rejection of
Arnulfo Velasco-Pacheco and Francisco J. Montijo)

RES. NO. 110-88

1 WHEREAS, the Tohono O'Odham Legislative Council did meet to hear
2 out the cases being recommended for rejection on their
3 request for enrollment into the Tohono O'odham Nation;
4 and

5 WHEREAS, after hearing out the reasons for making such
6 recommendations by the Enrollment Committee the Tohono
7 O'Odham Legislative Council determined that the basis
8 upon which the committee made their recommendation
9 needed further research.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham
11 Legislative Council hereby tables the recommendation for
12 rejection of the persons listed (see attachment).

13 BE IT FURTHER RESOLVED that the Enrollment work with the O'Odham
14 in Mexico Staff to do a thorough research on these
15 individuals.

16 The foregoing resolution was passed by the Tohono O'odham Council
17 on the 5th day of May, 1988 at a meeting at which a quorum was
18 present with a vote of 1,337.0 for; 181.0 against; 122.0 not
19 voting; and 03 absent, pursuant to the powers vested in the
20 Council by Section 1 (a) of Article VI of the Constitution of
21 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
22 on January 18, 1986, and approved by the Acting Deputy Assistant
23 Secretary - Indian Affairs (Operations) on March 6, 1986,
24 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
25 984).
