for enrollment as a member of the Tohono O'odham Nation is hereby rejected.

BE IT FURTHER RESOLVED that the Chairman of the Tohono O'odham Nation shall issue a Certification of Final Determination of rejection and that the Enrollment Committee serve Notice of Rejection of the application in accordance with the provisions under section 1 and 2 Article III of the Enrollment Ordinance.
