

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Rejection of membership application of
Angelica B. Valenzuela)

1 WHEREAS, an application for enrollment as a member of the Tohono
2 O'Odham Nation has been filed by or on behalf of:

3 Angelica B. Valenzuela

4 filed on the 31st. day of August, 1985; and

5 WHEREAS, the Enrollment Committee has reviewed the application
6 and has recommended that the application be denied
7 because the applicant failed to establish the following
8 membership requirement(s): TOHONO O'ODHAM CONSTITUTION,
9 ARTICLE II, MEMBERSHIP - SECTION (1A) & (1B); and

10 WHEREAS, the application has come on for hearing before this
11 Council; and

12 WHEREAS, the Enrollment Committee did serve written notice of its
13 recommendation to reject the application and of this
14 hearing, as required by Section 2, Article VI of the
15 Enrollment Ordinance, upon the person(s) who filed the
16 application(s) and such person(s) was not present at
17 this hearing; and

18 WHEREAS, the Tohono O'Odham Council has reviewed all of the
19 evidence presented and from such evidence finds that the
20 applicant(s) has failed to establish the foregoing
21 membership requirements.

22 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that
23 it does hereby determine that the application(s) of:

24 Angelica B. Valenzuela

25 for enrollment as a member of the Tohono O'odham Nation
26 is hereby rejected.

27 BE IT FURTHER RESOLVED that the Chairman of the Tohono O'odham
28 Nation shall issue a Certification of Final
29 Determination of rejection and that the Enrollment
30 Committee serve Notice of Rejection of the application
31 in accordance with the provisions under section 1 and 2
32 Article III of the Enrollment Ordinance.

1 The foregoing resolution was passed by the Tohono O'odham
2 Council on the 5th. day of May, 1988, at a meeting at which a
3 quorum was present with a vote of 1,480.5 for; -0- against; 159.5
4 not voting; and 03 absent; pursuant to the powers vested in the
5 Council by Article II and Section 1 (h) of Article VI of the
6 Constitution of the Tohono O'odham Nation, adopted by the Tohono
7 O'odham Nation on January 18, 1986, and approved by the Acting
8 Deputy Assistant Secretary - Indian Affairs (Operations) on March
9 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
10 Stat. 984).
