7 WHEREAS, the Enrollment Committee has reviewed the applications
8 and has recommended that the applications be denied
9 because the applicants failed to establish the following
10 membership requirement(s): TOHONO O'ODHAM CONSTITUTION,
11 ARTICLE II, MEMBERSHIP - SECTION (1A) & (1B); and

12 WHEREAS, the applications has come on for hearing before this
13 Council; and

14 WHEREAS, the Enrollment Committee did serve written notice of its
15 recommendation to reject the applications and of this
16 hearing, as required by Section 2, Article VI of the
17 Enrollment Ordinance, upon the person(s) who filed the
18 application(s) and such person(s) was not present at
19 this hearing; and

20 WHEREAS, the Tohono O'Odham Council has reviewed all of the
21 evidence presented and from such evidence finds that the
22 applicant(s) has failed to establish the foregoing
23 membership requirements.

24 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that
25 it does hereby determine that the application(s) of:

Article III of the Enrollment Ordinance.

not voting; and 05 absent; pursuant to the powers vested in the
Council by Article II and Section 1 (h) of Article VI of the
Constitution of the Tohono O'odham Nation, adopted by the Tohono
O'odham Nation on January 18, 1986, and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March
6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).
