

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Training for Housing and Natural Resources Committee)

RES. NO. 115-88

1 WHEREAS, the Tohono O'odham Legislative Council does not have
2 adequate funds to provide training for the Housing
3 Committee and Natural Resources Committee; and

4 WHEREAS, members of the Housing and Natural Resources Committee
5 did voice a concern that they need to become more
6 knowledgeable of the National laws and policies
7 regarding Indian Housing and Natural Resources
8 Management; and

9 WHEREAS, such training and academic instruction for the
10 committees will be beneficial in recommending policies
11 for Housing and Natural Resources for the Tohono O'odham
12 Nation.

13 NOW THEREFORE BE IT RESOLVED, that the Tohono O'odham Legislative
14 Council does hereby approve the request of the
15 Legislative Housing Committee to attend the training
16 entitled Housing for American Indians on May 24-26, 1988
17 in Reno, Nevada (see attachment).

18 BE IT FURTHER RESOLVED, that the Tohono O'odham Legislative
19 Council does also approve the request of the Natural
20 Resources Committee to attend the 1988 AIRI Summer
21 Institute on Tribal Natural Resources Management on June
22 13-29, 1988 in Boulder, Colorado (see attachment).

23 BE IT FURTHER RESOLVED, that the Tohono O'odham Legislative
24 Council does hereby authorize \$6,500.00 to be allocated
25 from the Administrative Provisions to cover all expenses
26 deriving from the training for the Housing Committee and
27 Natural Resources Committee.

28 The foregoing resolution was passed by the Tohono O'odham Council
29 on the 5th. day of May, 1988 at a meeting at which a quorum was
30 present with a vote of 1,459.0 for; 181.0 against; -0- not
31 voting; and 03 absent, pursuant to the powers vested in the
32 Council by Section 1(b) of Article VI of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
