- WHEREAS, members of the Housing and Natural Resources Committee did voice a concern that they need to become more knowledgeable of the National laws and policies regarding Indian Housing and Natural Resources Management; and
- WHEREAS, such training and academic instruction for the committees will be beneficial in recommending policies for Housing and Natural Resources for the Tohono O'odham Nation.
- NOW THEREFORE BE IT RESOLVED, that the Tohono O'odham Legislative Council does hereby approve the request of the Legislative Housing Committee to attend the training entitled Housing for American Indians on May 24-26, 1988 in Reno, Nevada (see attachment).
- BE IT FURTHER RESOLVED, that the Tohono O'odham Legislative Council does also approve the request of the Natural Resources Committee to attend the 1988 AIRI Summer Institute on Tribal Natural Resources Management on June 13-29, 1988 in Boulder, Colorado (see attachment).
- BE IT FURTHER RESOLVED, that the Tohono O'odham Legislative

 Council does hereby authorize \$6,500 ... to be allocated

 from the Administrative Provisions to cover all expenses

 deriving from the training for the Housing Committee and

 Natural Resources Committee.

The foregoing resolution was passed by the Tohono O'odham Council on the 5th. day of May, 1988 at a meeting at which a quorum was present with a vote of 1,459.0 for; 181.0 against; -0- not voting; and 03 absent, pursuant to the powers vested in the Council by Section 1(b) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
