WHEREAS, the Enrollment Committee did serve written notice of its recommendation to reject the application and of this hearing, as required by Section 2, Article VI of the Enrollment Ordinance, upon the person(s) who filed the application(s) and such person(s) were present at this hearing; and

WHEREAS, the Tohono O'Odham Council has reviewed all of the evidence presented and from such evidence determined that more research is necessary in light of the new documents presented by Charles Mendivil in behalf of Jose M. Mendivil and Jesus Romo Family.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council to refer the names of Jose M. Mendivil and Jesus Romo Family back to the Enrollment Committee for more research.

BE IT FURTHER RESOLVED that the Enrollment Committee work with the Hiatit O'Odham Program on their research.

The foregoing resolution was passed by the Tohono O'odham day of May, Council on the 6th. 1988, at a meeting at which a quorum was present with a vote of 1,035.5 for; -0- against; 382.5 not voting; and 07 absent; pursuant to the powers vested Council by Article II and Section 1 (h) of Article VI in the of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March pursuant to Section 16 of the Act of June 18, 1934 (48 6, 1986, Stat. 984).
