6 WHEREAS, the Enrollment Committee has reviewed the applications  
7 and has recommended that the applications be denied  
8 because the applicants failed to establish the following  
9 membership requirement(s): TOHONO O'ODHAM CONSTITUTION,  
10 ARTICLE II, MEMBERSHIP - SECTION (1A) & (1B); and

11 WHEREAS, the applications has come on for hearing before this  
12 Council; and

13 WHEREAS, the Enrollment Committee did serve written notice of its  
14 recommendation to reject the applications and of this  
15 hearing, as required by Section 2, Article VI of the  
16 Enrollment Ordinance, upon the person(s) who filed the  
17 application(s) and such person(s) was not present at  
18 this hearing; and

19 WHEREAS, the Tohono O'Odham Council has reviewed all of the  
20 evidence presented and from such evidence finds that the  
21 applicant(s) lack sufficient information to support the  
22 Enrollment Committee's recommendation for rejection.

23 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that

the Council by Article II and Section 1 (h) of Article VI of the  
Constitution of the Tohono O'odham Nation, adopted by the Tohono

1 O'Odham Nation on January 18, 1986, and approved by the Acting  
2 Deputy Assistant Secretary - Indian Affairs (Operations) on March  
3 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
4 Stat. 984).
