

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'Odham FY '89 Johnson O'Malley)

RES. NO. 126-88

1 WHEREAS, the Tohono O'odham Nation is presently operating the
2 Johnson O'Malley Program under FY 1988 P. L. 93-638
3 contract with the Bureau of Indian Affairs; and

4 WHEREAS, such tribal operations have been successful and
5 beneficial to the Tohono O'odham Nation and its people;
6 and

7 WHEREAS, 25 CFR Section 271.20 of the Federal Regulations
8 requires that all proposals to recontract under P. L.
9 93-638 be submitted to the Tohono O'Odham Council for
10 approval at least 120 days prior to the contract
11 termination; and

12 WHEREAS, the Tohono O'Odham Nation does desire to recontract for
13 provisions of these services during FY 1989; and

14 WHEREAS, the Tohono O'Odham Council has reviewed and approved the
15 FY 1989 Johnson O'Malley contract.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
17 Council that it does authorize and request the Bureau of
18 Indian Affairs to contract with the Tohono O'Odham
19 Nation under P. L. 93-638 regulations and procedures for
20 the provision of services titled: Johnson O'Malley.

21 BE IT FURTHER RESOLVED that the approved budget is subject to
22 change once a decision is made on the Cost of Living
23 Allowance (COLA) rate.

24 BE IT FURTHER RESOLVED that the duration of this contract will
25 commence on October 01, 1988 through September 30, 1989.

26 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
27 that the Tohono O'Odham Nation will not fund or operate
28 the program in the interim while negotiations are still
29 being conducted and no executed contract has been
30 awarded by the Bureau of Indian Affairs.

31 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
32 that the Chairman, Vice-Chairman and Treasurer of the
33 Tohono O'Odham Nation are hereby authorized to negotiate

and execute this contract and any amendments thereto for the duration of the contract, provided however, that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.

The foregoing resolution was passed by the Tohono O'odham Council on the 6th. day of June, 1988 at a meeting at which a quorum was present with a vote of 1,640.0 for; -0- against; -0- not voting; and 02 absent, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
