NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
 Council that it hereby approves amendment #4 with Pima
 Community College Skill Center for the delivery of
 training services to the Tohono O'Odham members.

21 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council 22 that the Tohono O'Odham Nation will not fund or operate 23 the program in the interim while negotiations are still 24 being conducted and no executed contract has been 25 awarded by the Tohono O'Odham Nation.

26FURTHER RESOLVED by the Tohono O'odham Legislative Council BE IT 27that the Chairman, Vice-Chairman and Treasurer of the 28Tohono O'Odham Nation are hereby authorized to negotiate 29and execute this contract and any amendments thereto for 30 the duration of the contract, provided however, that any 31 amendments affecting the funding or funding levels of 32 contract shall be submitted for further prior this approval by this Council.
