whereas, any amendments affecting the funding or funding levels of the contract shall be submitted for review and approval by the Tohono O'Odham Legislative Council; and whereas, an amendment has been submitted for review and approval by the Judicial Services Program.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby approve the amendment to the Judicial Services Contract.

Treasurer of the Tohono O'Odham Nation are hereby authorized to negotiate and execute the contract and any amendments thereto for the duration of the contract, provided however, that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.

The foregoing resolution was passed by the Tohono O'odham Council on the 6th. day of June , 1988 at a meeting at which a quorum was present with a vote of 1,640.0 for; -0- against; -0- not voting; and 02 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
