

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Support of the AIDS Education Project of the
Disease Prevention and Control Branch, TOHD)

2 WHEREAS, the Tohono O'odham Legislative Council is aware of the
3 health threat of the disease AIDS; and

4 WHEREAS, the Tohono O'odham Health Board of the Tohono O'odham
5 Nation has recognized that AIDS, as a communicable and
6 incurable disease, poses a public health threat for
7 members and/or residents of the Tohono O'Odham Nation;
8 and

9 WHEREAS, the Tohono O'Odham Health Board has mandated that the
10 Health Department develop an AIDS Prevention Program
11 which will be a community oriented education project;
12 and

13 WHEREAS, the Disease Prevention and Control Services Branch of
14 the Tohono O'Odham Health Department through its efforts
15 to apply for funding for AIDS education was informed by
16 the Indian Health Service that the IHS Clinical Services
17 Branch has released the sum of \$20,000.00 to each Area
18 Office for joint Service Unit/Tribal Health Department's
19 AIDS education projects.

20 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
21 Council that it does hereby approve the proposal for
22 funding for six (6) months the development of a joint
23 IHS Sells Service Unit/Tohono O'odham Health Department
24 education project for \$20,000.00 beginning August 1,
25 1988 to January 31, 1989.

26 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
27 that the Indirect Cost be exempt from the AIDS Project
28 Grant.

29 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
30 that the Tohono O'odham Nation will not fund or operate
31 the program in the interim while negotiations are still
32 being conducted and no executed contract has been
awarded by the Indian Health Service.

1 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
 2 that the Chairman, Vice-Chairman and Treasurer of the
 3 Tohono O'odham Nation are hereby authorized to negotiate
 4 and execute this contract and any amendments thereto for
 5 the duration of the contract, provided however, that any
 6 amendments affecting the funding or funding levels of
 7 this contract shall be submitted for further prior
 8 approval by this Council.

 10 The foregoing resolution was passed by the Tohono O'odham Council
 11 on the 7th day of June, 1988 at a meeting at which a quorum
 12 was present with a vote of 1,476.5 for; -0- against; 163.5 not
 13 voting; and 02 absent, pursuant to the powers vested in the
 14 Council by Section 1 (f) of Article VI of the Constitution of
 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
 on January 18, 1986, and approved by the Acting Deputy Assistant
 Secretary - Indian Affairs (Operations) on March 6, 1986,
 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
 984).
