

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adolescent Family Life Demonstration Project Grant)

RES. NO. 135-88

1 WHEREAS, the Tohono O'Odham Nation is presently operating the
2 Adolescent Family Life Demonstration Program under a
3 three (3) year grant with the Office of Adolescent
4 Pregnancy Program; and

5 WHEREAS, the Tohono O'Odham Legislative Council is desirous to
6 continue to protect and ensure the well-being of
7 adolescents, pregnant adolescents, adolescent parents,
8 their children and families; and

9 WHEREAS, it is the intent of the Tohono O'Odham Legislative
10 Council to better integrate and coordinate existing
11 health care resources available to adolescents.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
13 Council that it hereby approves the second year funding
14 for the Adolescent Family Life Demonstration Project
15 Grant, provided that the Health Department along with
16 the Maternal Child Health Branch pursue the development
17 of a policy that would be geared towards providing
18 services to both adolescent parents.

19 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
20 that the Tohono O'Odham Nation will not fund or operate
21 the program in the interim while negotiations are still
22 being conducted and no executed grant has been awarded
23 by the Office of Adolescent Pregnancy Program.

24 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
25 that the Chairman, Vice-Chairman and Treasurer of the
26 Tohono O'Odham Nation are hereby authorized to negotiate
27 and execute this grant and any amendments thereto for
28 the duration of the grant, provided however, that any
29 amendments affecting the funding or funding levels of
30 this grant shall be submitted for further prior approval
31 by this Council.

The foregoing resolution was passed by the Tohono O'odham Council on the 7th day of June, 1988 at a meeting at which a quorum was present with a vote of 1,640.0 for; -0- against; -0- not voting; and 02 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
