

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Usage of interest on the \$100,000.00 Economic
Development Project fund for Pisinemo District)

RES. NO. 137-88

1 WHEREAS, the Pisinemo District Council by District Resolution
2 Number 4-86 did request to withdraw their allocation of
3 \$100,000.00 Economic Development Project Fund from the
4 Bureau of Indian Affairs IIM Account to deposit in a
5 special banking account for the District; and

6 WHEREAS, the Legislative Council by Resolution No. 38-87 did
7 approve and authorize the request, and further, that the
8 funds remain in account until the District submits a
9 project proposal; and

10 WHEREAS, the Pisinemo District is now ready to work on their
11 project proposal and are requesting the Legislative
12 Council's approval and authorization to utilize
13 \$3,000.00 of the accrued interest on the \$100,000.00 .

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
15 Council that it does hereby approve and authorizes
16 Pisinemo District's request.

17 BE IT FURTHER RESOLVED that Pisinemo District work with the
18 Comptroller and Treasurer in recording and reporting
19 all expenditures and necessary information to the Tohono
20 O'Odham Nation's Accounting Office.

22 The foregoing resolution was passed by the Tohono O'odham Council
23 on the 7th. day of June , 1988 at a meeting at which a quorum
24 was present with a vote of 1,640.0 for; -0- against; -0- not
25 voting; and 04 absent, pursuant to the powers vested in the
26 Council by Section 1 (d) of Article VI of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
