WHEREAS, the Natural Resources Committee did review the status of BIA Road Construction and improvements for the last five years; and

WHEREAS, there is still a need to improve drainage problems, address heavy traffic problems and a need to seal and chip roads; and

WHEREAS, bus routes must be improved and/or constructed; and
WHEREAS, the Natural Resources Committee has identified six (6)
routes which need to be improved or need to be paved.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative

Council that the following routes are prioritized as

documented in the attachments and identified as the

following:

- 1. Sells Federal Route (19) to New Fields Federal Route (191)
- Fencing from Santa Rosa to Sif Oidak Boundary Federal Route 15
- 3. Highway 86 to San Pedro Federal Route 41
- 4. Highway 86 to Pan Tak Federal Route 39
- 5. Little Tucson Route 161
- 6. Kohatk Federal Route 42

BE IT FURTHER RESOLVED that the Chairman is authorized to execute whatever documents are necessary to accomplish the necessary roads to be constructed and/or improved according to the priorities listed for road improvement or construction as attached hereto and made a part hereof.

The foregoing resolution was passed by the Tohono O'odham Council on the 7th day of January, 1988, at a meeting at which a quorum was present with a vote of 1,438.0 for; 101.0 against; 101.0 not voting; and 01 absent; pursuant to the powers vested in the Council by Section I (j) of Article VI of the Constitution of the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
