(Domestic Affairs Committee Training Request)

1 WHEREAS, the Domestic Affairs Committee is requesting financial
2 assistance to attend the Federal Indian Law training
3 session to be held on June 28 - 30, 1988, in Reno,
4 Nevada; and

5 WHEREAS, the training session will provide a better understanding
6 of Federal and State Laws for the Domestic Affairs
7 Committee to carry out its day-to-day duties.

8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
9 Council that the financial assistance requested by the
10 Domestic Affairs Committee to attend the Federal Indian
11 Law training session is hereby approved.

12 The foregoing resolution was passed by the Tohono O'odham Council
13 on the 7th. day of June, 1988 at a meeting at which a quorum was
14 present with a vote of 1,640.0 for; -0- against; -0- not voting;
15 and 05 absent, pursuant to the powers vested in the Council by
16 Section 1(d)(3) of Article VI of the Constitution of the Tohono
O'odham Nation, adopted by the Tohono O'odham Nation on January
18, 1986, and approved by the Acting Deputy Assistant Secretary-
Indian Affairs (Operations) on March 6, 1986, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984).




