

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Base Roll Additions)

RES. NO. 140-88

1 WHEREAS, Section 1 (a) of Article II of the Constitution of the
2 Tohono O'Odham Nation provides that the Tohono O'Odham
3 Council can make additions and changes to the official
4 census rolls of the Sells and Gila Bend Reservations
5 dated January 1, 1937 and of the San Xavier Reservation
6 dated January 1, 1940, subject to the approval of the
7 Secretary of the Interior; and

8 WHEREAS, the Enrollment Committee has determined that the
9 following named persons were members of the Tohono
10 O'Odham Nation on the date of the respective census
11 rolls but that their names had been inadvertently
12 omitted therefrom, and had recommended that their names
13 be added to the rolls; and

14 WHEREAS, the Tohono O'Odham Council has reviewed the
15 recommendations of the Enrollment Committee and approves
16 thereof.

17 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council
18 that, subject to the approval of the Secretary of the
19 Interior, the names of the following persons be added to
20 the official census rolls of the Sells, Gila Bend or San
21 Xavier Reservation, to wit:

22 NORIEGO, Alice (Porter) 3029-S-88

23 BE IT FURTHER RESOLVED that the required approval be secured from
24 the Secretary of the Interior before their names be
25 formally added to such rolls.

26 The foregoing resolution was passed by the Tohono O'Odham
27 Council on the 8th. day of June, 1988, at a meeting at which a
28 quorum was present with a vote of 1,390.5 for; -0- against; 249.5
29 not voting; and 02 absent; pursuant to the powers vested in the
30 Council by Section 1 (a) of Article II and Section 1 (h) of
31 Article VI of the Constitution of the Tohono O'Odham Nation,
32 adopted by the Tohono O'Odham Nation on January 18, 1986, and
approved by the Acting Deputy Assistant Secretary - Indian
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984).
