technical assistance from the Tohono O'Odham Nation's
Credit and Finance Program in the realm of finances to
be in the best interest of the Sells District.

BE IT FURTHER RESOLVED that the Sells District Administration Staff has the option to seek other business investments to be in the best interest of the Sells District.

The foregoing resolution was passed by the Tohono O'odham Council on the 8th. day of June , 1988 at a meeting at which a quorum was present with a vote of 1,640.0 for; -0- against; -0- not voting; and 02 absent, pursuant to the powers vested in the Council by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
