1 WHEREAS, the Tohono O'Odham Legislative Council has reviewed the
2 amended FY '88 San Xavier District budget; and

3 WHEREAS, the Legislative Council has determined that additional
4 funds are required for the adequate operation and
5 management of the District; and

6 WHEREAS, additional funds have been identified to affect this
7 amendment.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
9 Legislative Council hereby approves the amendment of the
10 San Xavier District FY '88 budget in the amount of
11 \$18,184.10 from \$188,132.00 to \$206,316.10 .

13 The foregoing resolution was passed by the Tohono O'odham Council
14 on the 8th day of June, 1988 at a meeting at which a quorum was
15 present with a vote of 1,492.5 for; 84.5 against; 63.0 not
16 voting; and 03 absent, pursuant to the powers vested in the
17 Council by Section 1 (d)(3) of Article VI of the Constitution of
18 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
19 on January 18, 1986, and approved by the Acting Deputy Assistant
20 Secretary - Indian Affairs (Operations) on March 6, 1986,
21 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
22 984).
