

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Predesign & Design for the San Xavier Cooperative Farm
Rehabilitation Project Contract No. 8-CS-30-04830)

RES. NO. 146-88

1 WHEREAS, the Tohono O'Odham Nation is presently operating the San
2 Xavier Rehab Project under a P. L. 93-638 contract with
3 the Bureau of Reclamation; and

4 WHEREAS, any amendments affecting the funding of the contract
5 shall be submitted for review and approval by the Tohono
6 O'Odham Legislative Council; and

7 WHEREAS, an amendment has been submitted by the Tohono O'Odham
8 Nation's Central Arizona Water Project for review and
9 approval.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
11 Legislative Council does hereby approve the amendment to
12 the San Xavier Rehab Project Contract.

13 BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman and the
14 Treasurer of the Tohono O'Odham Nation are hereby
15 authorized to negotiate and execute the contract and any
16 amendments thereto for the duration of the contract,
17 provided however, that any amendments affecting the
18 funding or funding levels of the contract shall be
19 submitted for further prior approval by this Council.

21 The foregoing resolution was passed by the Tohono O'odham Council
22 on the 8th. day of June, 1988 at a meeting at which a quorum was
23 present with a vote of 900.5 for; 159.5 against; 580.0 not
24 voting; and 02 absent, pursuant to the powers vested in the
25 Council by Section 1 (f) of Article VI of the Constitution of
26 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
27 on January 18, 1986, and approved by the Acting Deputy Assistant
28 Secretary - Indian Affairs (Operations) on March 6, 1986,
29 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
30 984).
