

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham Management of Health Services)

RES. NO. 153-88

1 WHEREAS, the Tohono O'Odham Nation is presently operating the
2 Management of Health Services Program under FY '83 P. L.
3 93-638 contract with the Public Health Indian Health
4 Service; and

5 WHEREAS, such tribal operations have been successful and
6 beneficial to the Tohono O'Odham Nation and its people;
7 and

8 WHEREAS, 25 CFR Section 271.20 of the Federal Regulations
9 requires that all proposals to recontract under P. L.
10 93-638 be submitted to the Tohono O'Odham Council for
11 approval at least 120 days prior to the contract
12 termination; and

13 WHEREAS, the Tohono O'Odham Nation does desire to recontract for
14 provisions of these services during FY 1989; and

15 WHEREAS, the Tohono O'Odham Council has reviewed and approved the
16 Management of Health Services contract.

17 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that
18 it does authorize and request the Public Health Indian
19 Health Service to contract with the Tohono O'Odham
20 Nation under P. L. 93-638 regulations and procedures for
21 the provision of services titled: Management of Health
22 Services Program.

23 BE IT FURTHER RESOLVED that the approved budget is subject to
24 change once a decision is made on the Cost of Living
25 (COLA) rate.

26 BE IT FURTHER RESOLVED that the duration of this contract will
27 commence on October 01, 1988 through September 30, 1989
28 unless extended by mutual agreement of both parties.

29 BE IT FURTHER RESOLVED that the Tohono O'Odham Nation will not
30 fund or operate a program from which contracts are
31 requested herewith which have not been negotiated and
32 executed by the Indian Health Service prior to the start
of the funding year.

1 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
2 that the Chairman, Vice-Chairman and Treasurer of the
3 Tohono O'Odham Nation are hereby authorized to negotiate
4 and execute this contract and any amendments thereto for
5 the duration of the contract, provided however, that any
6 amendments affecting the funding or funding levels of
7 this contract shall be submitted for further prior
8 approval by this Council.


9 The foregoing resolution was passed by the Tohono O'odham Council
10 on the 20th. day of June, 1988 at a meeting at which a quorum
11 was present with a vote of 1,013.0 for; 206.5 against; 179.5
12 not voting; and 241.0 absent, pursuant to the powers vested in
13 the Council by Section 1 (f) of Article VI of the Constitution
14 of the Tohono O'odham Nation, adopted by the Tohono O'odham
15 Nation on January 18, 1986, and approved by the Acting Deputy
16 Assistant Secretary - Indian Affairs (Operations) on March 6,
17 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
18 Stat. 984).
