

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Rehabilitation and After Care Services Re-contract FY '89)

RES. NO. 156-88

1 WHEREAS, the Tohono O'Odham Nation is presently operating the
2 Rehabilitation and After Care Services for the Tohono
3 O'Odham Youth as required by P. L. 99-570 under FY '88
4 P. L. 93-638 contract with Public Health, Indian Health
5 Services; and

6 WHEREAS, such tribal operations have been successful and
7 beneficial to the Tohono O'Odham Nation and its people;
8 and

9 WHEREAS, 25 CFR Section 271.20 of the Federal Regulations
10 requires that all proposals to recontract under P. L.
11 93-638 be submitted to the Tohono O'Odham Council for
12 approval at least 120 days prior to the contract
13 termination; and

14 WHEREAS, the Tohono O'Odham Council has reviewed and approved the
15 Rehabilitation and After Care Services Contract.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
17 Council that it does authorize and request the Public
18 Health, Indian Health Service to contract with the
19 Tohono O'Odham Nation under P. L. 93-638 regulations and
20 procedures for the provision of services titled:
21 Rehabilitation and After Care Service.

22 BE IT FURTHER RESOLVED that the approved budget is subject to
23 change once a decision is made on the Cost of Living
24 Allowance (COLA) rate.


25 BE IT FURTHER RESOLVED that the duration of this contract will
26 commence on October 01, 1988 and end September 30, 1989
27 unless extended by mutual agreement of both parties.

28 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
29 that the Tohono O'Odham Nation will not fund or operate
30 a program from which contracts are requested herewith
31 which have not been negotiated and executed by the
32 Indian Health Service prior to the start of the funding
year.

1 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
2 that the Chairman, Vice-Chairman and Treasurer of the
3 Tohono O'Odham Nation are hereby authorized to negotiate
4 and execute this contract and any amendments thereto for
5 the duration of the contract, provided however, that any
6 amendments affecting the funding or funding levels of
7 this contract shall be submitted for further prior
8 approval by this Council.

9 The foregoing resolution was passed by the Tohono O'odham Council
10 on the 20th day of June, 1988 at a meeting at which a quorum
11 was present with a vote of 1,076.0 for; 201.5 against; 121.5
12 not voting; and 241.0 absent, pursuant to the powers vested in
13 the Council by Section 1 (f) of Article VI of the Constitution
14 of the Tohono O'odham Nation, adopted by the Tohono O'odham
15 Nation on January 18, 1986, and approved by the Acting Deputy
16 Assistant Secretary - Indian Affairs (Operations) on March 6,
17 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
18 Stat. 984).
