- WHEREAS, the Tohono O'Odham Nation is presently operating the Rehabilitation and After Care Services for the Tohono O'Odham Youth as required by P. L. 99-570 under FY '88 P. L. 93-638 contract with Public Health, Indian Health Services; and
- WHEREAS, such tribal operations have been successful and beneficial to the Tohono O'Odham Nation and its people; and
- WHERBAS, 25 CFR Section 271.20 of the Federal Regulations requires that all proposals to recontract under 93-638 be submitted to the Tohono O'Odham Council for approval at least 120 days prior to the contract termination; and
- WHEREAS, the Tohono O'Odham Council has reviewed and approved the Rehabilitation and After Care Services Contract.
- NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does authorize and request the Public Health, Indian Health Service to contract with the Tohono O'Odham Nation under P. L. 93-638 regulations and procedures for the provision of services titled: Rehabilitation and After Care Service.
- BE IT FURTHER RESOLVED that the approved budget is subject to change once a decision is made on the Cost of Living Allowance (COLA) rate.
- BE IT FURTHER RESOLVED that the duration of this contract will commence on October 01, 1988 and end September 30, 1989 unless extended by mutual agreement of both parties.
- BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation will not fund or operate a program from which contracts are requested herewith which have not been negotiated and executed by the Indian Health Service prior to the start of the funding year.

The foregoing resolution was passed by the Tohono O'odham Council on the 20th. day of June , 1988 at a meeting at which a quorum was present with a vote of 1,076.0 for; 201.5 against; 121,5 not voting; and 241.0 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
