

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Tohono O'Odham Employment Assistance Program)


RES. NO. 161-88

1 WHEREAS, the Tohono O'Odham Nation is presently operating the  
2 Employment Assistance Program under FY '88 P. L. 93-638  
3 contract with the Bureau of Indian Affairs; and  
4 WHEREAS, such tribal operations have been successful and  
5 beneficial to the Tohono O'Odham Nation and its people;  
6 and  
7 WHEREAS, 25 CFR Section 271.20 of the Federal Regulations  
8 requires that all proposals to recontract under P. L.  
9 93-638 be submitted to the Tohono O'Odham Council for  
10 approval at least 120 days prior to the contract  
11 termination; and  
12 WHEREAS, the Tohono O'Odham Nation does desire to recontract for  
13 provisions of these services during FY 1989; and  
14 WHEREAS, the Tohono O'Odham Council has reviewed and approved the  
15 Employment Assistance contract.  
16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative  
17 Council that it does authorize and request the Bureau of  
18 Indian Affairs to contract with the Tohono O'Odham  
19 Nation under P. L. 93-638 regulations and procedures for  
20 the provision of services titled: Employment  
21 Assistance.  
22 BE IT FURTHER RESOLVED that the approved budget is subject to  
23 change once a decision is made on the Cost of Living  
24 Allowance (COLA) rate.  
25 BE IT FURTHER RESOLVED that the duration of this contract will  
26 commence on October 01, 1988 through September 30, 1989.  
27 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council  
28 that the Tohono O'Odham Nation will not fund or operate  
29 the program from which contracts are requested herewith  
30 which have not been negotiated and executed by the  
31 Bureau of Indian Affairs prior to the start of the  
32 funding year.


1 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council  
2 that the Chairman, Vice-Chairman and Treasurer of the  
3 Tohono O'Odham Nation are hereby authorized to negotiate  
4 and execute this contract and any amendments thereto for  
5 the duration of the contract, provided however, that any  
6 amendments affecting the funding or funding levels of  
7 this contract shall be submitted for further prior  
8 approval by this Council.

9 The foregoing resolution was passed by the Tohono O'odham Council  
10 on the 20th. day of June, 1988 at a meeting at which a quorum  
11 was present with a vote of 1,399.0 for; -0- against; -0- not  
12 voting; and 241.0 absent, pursuant to the powers vested in the  
13 Council by Section 1 (f) of Article VI of the Constitution of  
14 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
15 on January 18, 1986, and approved by the Acting Deputy Assistant  
16 Secretary - Indian Affairs (Operations) on March 6, 1986,  
17 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.  
18 984).
