

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Employment Assistance Budget Amendment)

RES. NO. 162-88

1 WHEREAS, the Tohono O'Odham Nation is presently operating the
2 Employment Assistance Program under FY '88 P. L. 93-638
3 contract with the Bureau of Indian Affairs; and

4 WHEREAS, any amendments affecting the funding and funding levels
5 of the contract shall be submitted for review and
6 approval by the Tohono O'Odham Legislative Council; and

7 WHEREAS, an amendment has been submitted for review and approval
8 by the Employment Assistance Program.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
10 Legislative Council does hereby approve the amendment to
11 the Employment Assistance Contract.

12 BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman and the
13 Treasurer of the Tohono O'Odham Nation are hereby
14 authorized to negotiate and execute the contract and any
15 amendments thereto for the duration of the contract,
16 provided however, that any amendments affecting the
17 funding and funding levels of this contract shall be
18 submitted for further prior approval by this Council.


19 The foregoing resolution was passed by the Tohono O'odham Council
20 on the 20th. day of June, 1988 at a meeting at which a quorum
21 was present with a vote of 1,399.0 for; -0- against; -0- not
22 voting; and 241.0 absent, pursuant to the powers vested in the
23 Council by Section 1 (f) of Article VI of the Constitution of
24 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
25 on January 18, 1986, and approved by the Acting Deputy Assistant
26 Secretary - Indian Affairs (Operations) on March 6, 1986,
27 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
28 984).
