

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adoption into the Tohono O'Odham Nation)

RES. NO. 171-88

1 WHEREAS, ERNESTO ESTEVAN has made application for adoption in the  
2 Tohono O'Odham Nation pursuant to Section 2 of Article  
3 II of the Constitution of the Tohono O'Odham Nation; and

4 WHEREAS, the Enrollment Committee has reviewed his respective  
5 application, and has made a final determination that he  
6 is 1/2 degree or more of Papago-Tohono O'Odham Indian  
7 blood, and have made a recommendation to the Tohono  
8 O'Odham Council that his application be approved, all in  
9 accordance with the provisions of the Enrollment  
10 Ordinance; and

11 WHEREAS, the Tohono O'Odham Council has reviewed the  
12 recommendation of the Enrollment Committee and the  
13 evidence submitted in support of the individual's  
14 application.

15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that  
16 the application for adoption filed by:

17 Ernesto Estevan 156-ND-88

18 is hereby approved and is hereby adopted into  
19 membership of the Tohono O'Odham Nation.

20 The foregoing resolution was passed by the Tohono O'Odham  
21 Council on the 5th. day of July, 1988, at a meeting at which a  
22 quorum was present with a vote of 1,523.0 for; -0- against; 117.0  
23 not voting; and 02 absent; pursuant to the powers vested in the  
24 Council by Section 2 of Article II and Article VI Section 1 (h)  
of the Constitution of the Tohono O'Odham Nation, adopted by the  
Tohono O'Odham Nation on January 18, 1986, and approved by the  
Acting Deputy Assistant Secretary - Indian Affairs (Operations)  
on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
1934 (48 Stat. 984).
