1 WHEREAS, the Budget and Finance Committee submitted its
2 recommendation to the Legislative Council on the
3 disbursement of the \$660,810.12 owed to the All
4 District's Account; and

5 WHEREAS, the Budget and Finance Committee recommended the
6 distribution of the \$660,810.12 in accordance with the
7 number of votes assigned per district.

8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
9 Council that the \$660,810.12 be distributed to the
10 eleven (11) Districts in accordance with the number of
11 votes assigned to the District.


12 The foregoing resolution was passed by the Tohono O'odham Council
13 on the 5th day of July, 1988 at a meeting at which a quorum was
14 present with a vote of 1,375.5 for; 85.0 against; 179.5 not
15 voting; and 02 absent, pursuant to the powers vested in the
16 Council by Section 1 (d) of Article VI of the Constitution of
17 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
18 on January 18, 1986, and approved by the Acting Deputy Assistant
19 Secretary - Indian Affairs (Operations) on March 6, 1986,
20 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
21 984).
