

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Sells District HUD Housing Request)

RES. NO. 177-88

1 WHEREAS, the Sells District Council at its regularly scheduled
2 meeting on June 18, 1987 discussed the need of more land
3 for residential assignments; and

4 WHEREAS, the Tohono O'Odham Nation has established a Housing
5 Authority for the purpose of obtaining Mutual Help HUD
6 through the Department of Housing Urban Development; and

7 WHEREAS, there is an urgent need for Housing Development in the
8 Sells District for the Sells Community; and

9 WHEREAS, the Sells District Council has discussed this matter and
10 believes this to be in the best interest of the
11 District.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
13 Legislative Council does support the resolution of the
14 Sells District Council and will submit application for
15 Mutual Help HUD Housing.

16 The foregoing resolution was passed by the Tohono O'odham Council
17 on the 6th day of July, 1988 at a meeting at which a quorum was
18 present with a vote of 989.5 for; 84.5 against; 566.0 not
19 voting; and 01 absent, pursuant to the powers vested in the
20 Council by Section 1 (f) of Article VI of the Constitution of
21 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
22 on January 18, 1986, and approved by the Acting Deputy Assistant
23 Secretary - Indian Affairs (Operations) on March 6, 1986,
24 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
25 984).
