

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM COUNCIL
(Referring the Water Distribution Study Contract
No. 7-CS-30-05900 Budget Modification #8 to the
Water Resources Committee)

LEGIS. ORDER NO. 180-88

1 WHEREAS, the Water Project Office presented the Water
2 Distribution Study Contract #7-CS-30-05900, Budget
3 Modification Number 8 to the Tohono O'odham Legislative
4 Council for approval; and

5 WHEREAS, the modification increases the contract amount of
6 \$532,297.00 by \$106,715.00 for Project Management,
7 Development Plans, Environmental Work and Land
8 Classification; and

9 WHEREAS, the budget modification is unclear on what bases the
10 criteria used to determine cost percentages for each of
11 the categories was made; and

12 WHEREAS, the activities should also include justification for the
13 cost requested, the work that needs to be done and the
14 work already completed.

15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham
16 Legislative Council hereby refers the Water Distribution
17 Study Contract Number 7-CS-30-05900, Budget Modification
18 Number 8 back to the Water Resources Committee for
19 further clarification as requested by Councilwoman
20 Rosita Ruiz.

23 Council on the 7th. day of July, 1988 at a meeting at which a
24 quorum was present with a vote of 950.0 for; 690.0 against; -0-
25 not voting; and 03 absent, pursuant to the powers vested in the
26 Council by Section 1 (b) of Article VI of the Constitution of
27 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
