WHEREAS, any amendments affecting the funding or funding levels of the contract shall be submitted for review and approval by the Tohono O'odham Legislative Council; and WHEREAS, an amendment has been submitted by the Tohono O'odham

Nation's Central Arizona Water Project Office for review and approval.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby approve the amendment to the Schuk toak Predesign Contract.

BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman and Treasurer of the Tohono O'odham nation are hereby authorized to negotiate and execute the contract and any amendments thereto for the duration of the contract, provided however, that any amendments affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.

The foregoing resolution was passed by the Tohono O'odham Council on the 7th. day of July , 1988 at a meeting at which a quorum was present with a vote of 1,417.5 for; -0- against; 222.5 not voting; and 01 absent, pursuant to the powers vested in the 1 (f) of Article VI of the Constitution of Council by Section the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
