

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(H.R. 2506, Border Crossing Bill)

RES. NO. 186-88

1 WHEREAS, the Legislative Council did by Resolution No. 127-87  
2 request Congress to enact a law which would recognize  
3 the right of any person of Tohono O'Odham descent who is  
4 not a citizen of the United States to pass and repass  
5 freely the borders of the United States and live and  
6 work in the United States; and

7 WHEREAS, in response to such request, Congressman Morris K. Udall  
8 did introduce H.R. 2506 and the Committee on Interior  
9 and Insular Affairs did conduct hearings thereon; and


10 WHEREAS, Ross O. Swimmer, Assistant Secretary of the Interior,  
11 did by letter dated June 21, 1988, provide the committee  
12 with the Administration's response to H.R. 2506 and did  
13 suggest an Amendment to H.R. 2506 in the nature of a  
14 substitute bill; and

15 WHEREAS, the Legislative Council is advised that the matter will  
16 come up for the mark-up before the committee on July 13,  
17 1988, and has serious objections to provisions in the  
18 substitute bill which cannot be properly addressed in  
19 time.

20 NOW, THEREFORE, BE IT RESOLVED that in view of the  
21 Administration's refusal to support H.R. 2506 in its  
22 current form the Legislative Council does hereby  
23 withdraw H.R. 2506 from further consideration during  
24 this session of Congress.

25 The foregoing resolution was passed by the Tohono O'odham Council  
26 on the 8th day of July, 1988 at a meeting at which a quorum was  
27 present with a vote of 1,640.0 for; -0- against; -0- not  
28 voting; and 02 absent, pursuant to the powers vested in the  
29 Council by Section 1(j) of Article VI of the Constitution of  
30 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
31 on January 18, 1986, and approved by the Acting Deputy Assistant  
32 Secretary - Indian Affairs (Operations) on March 6, 1986,  
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.  
984).
