(Adoption into the Tohono O'Odham Nation)

1 WHEREAS, SINOHUE, Pedro Sr. has made an application for adoption
2 in the Tohono O'Odham Nation pursuant to Section 2 of
3 Article II of the Constitution of the Tohono O'Odham
4 Nation; and

5 WHEREAS, the Enrollment Committee has reviewed his respective
6 application, and has made a final determination that he
7 is 1/2 degree or more of Papago-Tohono O'Odham Indian
8 blood, and have made a recommendation to the Tohono
9 O'Odham Council that his application be approved, all in
10 accordance with the provisions of the Enrollment
11 Ordinance; and

12 WHEREAS, the Tohono O'Odham Council has reviewed the
13 recommendation of the Enrollment Committee and the
14 evidence submitted in support of the individual
15 application.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that

26 not voting; and 01 absent; pursuant to the powers vested in the
27 Council by Section 2 of Article II and Article VI Section 1 (h)
28 of the Constitution of the Tohono O'odham Nation, adopted by the
29 Tohono O'Odham Nation on January 18, 1986, and approved by the
30 Acting Deputy Assistant Secretary - Indian Affairs (Operations)
31 on March 6, 1986, pursuant to Section 16 of the Act of June 18,
32 1934 (48 Stat. 984).
