

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Establishing the position of Chief Financial Officer)  
and prescribing the duties)

RES. NO. 189-88

1  
2 WHEREAS, the Budget and Finance Committee of the Legislature,  
3 (the Committee), presented a report to the Tohono  
4 O'odham Legislative Council, (the Legislature),  
5 containing certain recommendations concerning the  
6 condition and status of the Tohono O'odham Nation's  
7 Financial System, and:

8 WHEREAS, the Legislature by the enactment of Resolution #188-  
9 88, did approve of the recommendations presented by the  
10 Committee; and

11 WHEREAS, the Committee further recommends that the position of  
12 Chief Financial Officer, (attached Prescribed Duties of  
13 the Chief Financial Officer) be established for the  
14 interim period of 90 days, subject to extensions by the  
15 Legislature in order to provide for the security of the  
16 Nation's financial management system, and:

17 WHEREAS, Ms. Juanita Parvello is qualified to assume the duties  
18 of Chief Financial Officer and the Committee does  
19 recommend for her appointment; and

20 WHEREAS, Article VI, Section 1. (b) of the Constitution of the  
21 Tohono O'odham Nation provides that the Legislature  
22 shall have the power " To provide for, appoint, or  
23 provide for the appointment of, and prescribe the  
24 duties and powers of committees, boards, officers and  
25 agents; to establish and regulate subordinate  
26 organizations for business purposes; provided that no  
27 such committee, board, officer, agent, or organization  
28 shall exercise powers of the Tohono O'odham Council  
29 unless they are expressly delegated by the Tohono  
30 O'odham Council.", (emphasis added), and:

31 WHEREAS, Resolution #83-88, Adoption of the Budget and Finance  
32 Committee's Plan of Operation, provides the Committee  
with prescribed duties and powers as enumerated under

1 Section 1. (b), (1) through Section 1. (b), (7) of the  
2 Plan, authorizing the Committee to maintain oversight  
3 over the fiscal powers of the Legislative Council.

4 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
5 Council, that the position of the Chief Financial  
6 Officer is hereby established for an interim period of  
7 90 days, subject to extension by the Legislature.

8 BE IT FURTHER RESOLVED, that the Prescribed Duties of the Chief  
9 Financial Officer, attached, are hereby approved.

10 BE IT FURTHER RESOLVED, that Ms. Juanita Parvello is hereby  
11 appointed to the position of Chief Financial Officer,  
12 for a period of 90 days, subject to extensions by this  
13 Council.

14 BE IT FURTHER RESOLVED, that the Accounting Office budget is  
15 hereby modified to reprogram the remaining balance of  
16 funds allocated to the position of Treasurer to provide  
17 funds for the salary of the Chief Financial Officer.

18 BE IT FINALLY RESOLVED, that the Budget and Finance Committee  
19 shall monitor the activities of the Chief Financial  
20 Officer and maintain oversight over the fiscal powers  
21 of the Legislative Council.

23 The foregoing resolution was passed by the Tohono O'odham Council  
24 on the 15th. day of July, 1988 at a meeting at which a quorum  
25 was present with a vote of 1,470.5 for; -0- against; 52.5 not  
26 voting; and 117.0 absent, pursuant to the powers vested in the  
27 Council by Section 1 (b) of Article VI of the Constitution of  
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
on January 18, 1986, and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986,  
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.  
984).
