

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Reauthorizing Opening Of and Withdrawals from Bank Accounts)

RES. NO. 190-88

2 WHEREAS, under the Constitution of the Tohono O'odham Nation the
3 Treasurer of the Tohono O'odham Nation is charged with
4 the acceptance, receipt and safekeeping of all tribal
5 funds, and with the deposit of such funds as directed by
6 the Legislative Council; and

7 WHEREAS, the Treasurer's position has been vacant for over a
8 year, the Legislative Council did by Res. No. 189-88
9 establish the position of Chief Financial Officer with
10 prescribed duties and responsibilities "for receiving,
11 safekeeping and disbursement of the Nation's funds.
12 Also responsible for protecting the Nation's interest in
13 all financial matters."

14 NOW THEREFORE, BE IT RESOLVED by the Legislative Council that the
15 Chief Financial Officer is hereby authorized to open
16 and maintain such checking, savings or other banking
17 accounts in the name and on behalf of the Tohono O'odham
18 Nation.

19 BE IT FURTHER RESOLVED that, until further order of this Council,
20 any funds of the Tohono O'odham Nation deposited in such
21 accounts be subject to withdrawal or charge at any time
22 upon checks, notes, drafts, bills of exchange,
23 acceptances, undertakings or other instruments or orders
24 for the payment when made, signed, drawn, accepted, or
25 endorsed on behalf of the Tohono O'odham Nation by any
26 two of the following officers, namely the Chief
27 Financial Officer, the Chairman and Vice Chairman of the
28 Nation.

29 BE IT FURTHER RESOLVED that the Secretary or any other officer of
30 the Legislative Council from time to time in office is
31 authorized to verify the names of the officers of the
32 Legislative Council and Executive Department and their
respective offices, together with specimens of their

2 signatures, and in case of any change of any holder or
3 holders of any such office or offices, the fact of such
4 change and the names of any new officers and the offices
5 respectively held by them, together with specimens of
6 their signatures.

7 The foregoing resolution was passed by the Tohono O'odham Council
8 on the 15th day of July, 1988 at a meeting at which a quorum
9 was present with a vote of 1,640.0 for; -0- against; -0- not
10 voting; and 04 absent, pursuant to the powers vested in the
11 Council by Section 1 (d) of Article VI of the Constitution of
12 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
13 on January 18, 1986, and approved by the Acting Deputy Assistant
14 Secretary - Indian Affairs (Operations) on March 6, 1986,
15 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
16 984).
